If monies to which I am not entitled are transmitted by my employer to my Iowa Advisor account, I authorize my employer to redeem on my behalf Option shares in the amount necessary to obtain the return of the entire amount of these monies. I authorize the applicable Option and its transfer agent to follow all instructions by my employer in connection with transactions made under the Plan, including the redemption of Option shares, and I agree not to make claims against Iowa Advisor 529 Plan, its Program Manager, transfer agent, distributor, or Board for following the instructions of my employer. The availability of funds in my account is subject to verification of the transfer. The terms of the Plan may be terminated or modified at any time and without notice. I understand and agree to the terms set forth herein.
